Prof. Dr. Dieter Bögenhold has taught and carried out research at various universities in Germany, Italy, Finland, and Sweden and is currently a Professor in the Faculty of Economics and Management at the Alpen-Adria University at Klagenfurt, Austria. He teaches courses such as Principles of Entrepreneurship and Innovation and Markets in Socioeconomic Perspective, and his research focuses on Business Economics, Business Ethics, Economic Sociology, and Political Economy. Dieter has published contributions. including 18 books, book chapters. scholarly journals, working papers, lecture notes, and conference papers. Many of them have been published in Journals indexed in the ABS and CNRS lists. Dieter Bögenhold has been an Invited Speaker in several International Conferences (e.g., 90th International Atlantic Economic Society Conference; 4th International Conference on Management in Emerging Markets, and the 11th International Conference on Innovation, Entrepreneurship and Small Business; 110th Conference of the American Sociological Association, etc.) and served as Keynote Speaker at some international conferences at different continents.

Moreover, he has acted as a member of the Organizing and Programme Committee of many conferences (e.g., International Conference "Globalization and Youth: Developments, Analyses and Perspectives"; The 7th International Conference on Innovation Management, Entrepreneurship, and Sustainability, 87th International Atlantic Economic Conference, etc.). He is also Associate Editor of the *International Journal of Sociology and Criminology* (ISSN 1929-4409). In addition, Dieter is a member of the board of diverse *Associations* and *Journals* (e.g., *International Review of Entrepreneurship*; *Global Economy Review*; *SN Business & Economics*; *Lifescience Global*, etc.). Also, he acts as a reviewer for several scholarly *Journals*.

Finally, Prof. Dr. Bögenhold acts as a member of the Board of the *European Academy* of *Management* (elected Co-Chair of the Country Representatives Council), board member and chair of the VHB Committee on Scientific Theory and Business Ethics,

and he has participated in several competitively funded Research Projects. His articles have appeared in scholarly Journals such as Journal of Management & Organization, Empirica, Journal of Enterprising Communities, Employment and Society, Work, Employment and Society, Industrial Relations Journal, American Journal of Economics and Sociology, International Advances in Economic Research, International Review of Sociology, International Journal of Manpower, International Journal of Entrepreneurship and Innovation Management, Journal of Evolutionary Economics, American Behavioral Scientist, Small Business Economics, International Review of Entrepreneurship, International Journal of Entrepreneurial Venturing etc.

In 2021 "Neglected Links in Economics and Society - Inequality, Organization, Work and Economic Methodology" (London: Palgrave Macmillan Publishers 2021, sec. edition in 2022) was published and his edition of a book section on "Theory of Economic Theorizing" within the 2 volumes "History of Human Sciences" (ed., in 2022).
